Editorial

The Chair honors the memory of its cherished founder, Professor Raimondo Cagiano de Azevedo, who passed away on January 3rd, 2025, leaving an enduring legacy of scholarship, vision and humanity, and inspiring generations to come. Professor Emeritus of Demography at Sapienza University of Rome, he served as Dean of the Faculty of Economics from 1996 to 2002 and as Rector's Delegate for International Relations from 2005 to 2012.

A figure of extraordinary academic and human stature, his career stands as an enduring example of dedication to educating new generations committed to the study of population issues and European integration. Among his many appointments, he served for over thirty years as the Italian Government's Delegate to the Council of Europe's Population Committee, where he was also the Chairholder of the position.

At the beginning of the 2000s, he conceived the idea of creating a laboratory to promote cultural diversity and elaborate scenarios for the future of migration, recognizing population, migration, and development as some of the key issues of concern of the time. He believed international migrations were evolving as a result of the global transformations affecting the world, and he saw migration as an opportunity to foster growth and development as well as strengthen intercultural relations.

However, migration was (and is) often understood as a problem. Indeed, the increased population flows across borders of individuals from diverse cultural backgrounds have given rise to a number of challenges in both origin and destination countries. Over the years it was becoming increasingly clear that unilateral approaches would not be sufficient to address these challenges and that the international community needed to collectively find ways of benefitting from the positive effects of migration.

Out of this vision, in 2008 he founded our UNESCO Chair in Population, Migration and Development — the first UNESCO Chair hosted by Sapienza University. Under his guidance, the Chair has successfully contributed to building capacity in teaching and in research and to promoting a multidisciplinary scientific approach in the field of development, population and migrations, with the basic premise that human rights should be at the core of any approach to human mobility.

Were he with us today, he would remind us that the *acquis communautaire* (a set of rights and duties that Europeans have given themselves over the past decades and that more than anything distinguish the "European model" in the world) is a new frontier among extra-European migrants, asylum seekers and Europeans to be progressively crossed thanks to the access to rights, citizenship and to the fight against any form of discrimination. The answer to the request of *acquis communautaire*, which arises from migrants' mobility, is to be found in a European subsidiarity approach: at the local level, the solutions to the problems of integration and interculturalism, at the national level, the planning of legal flows, and at the supranational level, the political governance of migration flows including relations with the sending countries.

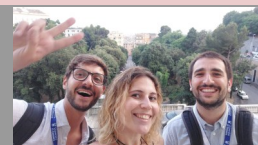

MAPS Conference**Migration and Displacement in Sub-Saharan Africa: Towards a knowledge-based Agenda | 28 July 2025 - Serena Hotel, Dar es Salaam, Tanzania | Hybrid modality**

The MAPS Conference 2025 served as an interactive forum for scholars, policymakers, and stakeholders to exchange knowledge on migration and displacement in Sub-Saharan Africa. Supported by the EU, it gathered diverse actors from ten African countries and Europe to discuss human rights, gender equality, and sustainability.

The conference opened with institutional remarks from distinguished representatives, including Razack Bakari Lokina of the University of Dodoma, Giuseppe Coppola, Ambassador of Italy to Tanzania, Maurizio Busatti of the International Organization for Migration, Sobhi Tawil from UNESCO, Marc Stalmans of the European Union Delegation, and Anna Peter Makakala from the Tanzanian Ministry of Interior. Their interventions highlighted the shared responsibility in addressing displacement and underscored the importance of knowledge exchange between African and European institutions.

Four thematic roundtables addressed peace, people, planet, and prosperity, fostering dialogue on key migration challenges and solutions. The Conference concluded with a strong commitment to advance a knowledge-based agenda on migration and displacement in Sub-Saharan Africa, by fostering academic and policy cooperation between Africa and Europe, strengthening data governance, and promoting holistic and sustainable approach.
