

Research projects

COVINFORM - Giorgio Alleva, Elena Ambrosetti, Alessandra De Rose, Sara Miccoli, Donatella Strangio and Marina Zannella participated in the Horizon 2020 project COVINFORM - *COronavirus Vulnerabilities and INFOrmation dynamics Research and Modelling* (2020-2023). The aims of the project are to assess COVID-19 responses in a multilevel governance framework and to develop toolkit for stakeholders in the governmental, public health, and civil society/community domains.

PRIN - **Immigration, integration, settlement. Italian-Style** - **Angela Paparusso** participated in the project funded by MIUR (2019-2022) whose the main goal is to provide a multidimensional understanding of the process of insertion of foreign immigrants in Italy. The project will make use of new sources of information on migrants in Italy that allows to develop a wide analysis of their settlement process into the Italian society.

FUME - Angela Paparusso participated in the Horizon 2020 project FUME - *Future Migration Scenarios for Europe* (2020-2022).
