International Workshop "Migrations in the Mediterranean. Across Borders and Disciplines" Sapienza University December 9-10, 2014 **Cormac Ó Gráda.** Irish economist. He is professor of economics at University College Dublin, and a prolific author of books and academic papers. As a historian of economics, his most quoted works are on the Irish famine of the late 1840s, and studies of fluctuations in the Irish population. Over 100 of his academic papers are available online. He is a member of the Cliometric Society, the Economic History Society, the European Historical Economics Society, the Irish Economic and Social History Society and the Royal Irish Academy. He is also a co-editor for the European Review of Economic History, a learned journal. He also contributes to the "Irish Economy" blogging website.

**Joaquin Arango**. Professor of Sociology, Complutense University of Madrid, and Director, Center for the Study of Migration and Citizenship, Ortega y Gasset Research Institute. Until recently, he was President of Spain's National Forum for the Social Integration of Immigrants, and member of the Group of Experts 'EuroMed-2030' of the European Commission. He is co-editor of the Yearbook of Immigration and Immigration Policies (Spain), and serves on the editorial boards of several scientific journals and a number of advisory committees. In the 1990s, he was the Director of the Spanish National Centre for Sociological Research. His current areas of interest include migration systems and migration regimes, migration and integration policies, labor migration, irregular migration, and the impacts of the economic crisis. Current or recent research projects, which he has led or participated in, have dealt with irregular migration and the underground economy, the impact of admission policies on integration, attitudes towards immigration and diversity, and migrant domestic workers. He has supervised a large number of graduate and doctoral students and worked as an expert for the European Commission, the Council of Europe, ILO, OECD, and other international institutions.

**Ivana Fellini**. She holds a Phd in Sociology and Social Research. She is assistant professor in Sociology of economic processes and labour at the Department of Sociology and Social Research of the University of Milano-Bicocca. Her main research interests cover labour market and employment patterns of change, with focus on gender, immigration and flexibility issues. She recently published contributions on the impact of the crisis on the employment structure and on the change of the employment forms in the post-industrial asset.

**Giovanna Fullin**. She holds a Phd in Economic Sociology. She is assistant professor (Sociology of economic processes and labour) at the Department of Sociology and Social Research - University of Milan Bicocca. Her aain research interests are: sociology of labour market and, in particular, migrations and labour market, front line service workers, work and occupations in the service sector, domestic services, non-standard jobs. She published a book on non-permanent workers in Italy (Vivere l'instabilità del lavoro, il Mulino 2004) and several articles in scientific journals concerning immigrants in the labour market (see in particular the special issues of "International Migration" (n.49, 2011) and "International Journal of Comparative Sociology" (n.52, 2011) edited with Emilio Reyneri).

**Emilio Reyneri**. Emeritus Professor of Sociology of Work at the Department of Sociology and Social Research, University of Milan Bicocca. For years, he taught at the Universities of Parma and Catania. From 1998 to 2001 he was member of the Committee for policies for integrating immigrants appointed by Italian Government. His main topics of research are labour market, labour policies and migration. From 1996 to 1999, he was the European co-ordinator of an EU-TSER project on "Migrants' insertion in the informal economy, deviant behaviour and the impact on receiving societies". From 2005 to 2010, he was Member of the Governing Council of the Network of excellence EQUALSOC (Economic Change, Quality of life and Social Cohesion). Since 2011 he was appointed by Istat in a Scientific Commission for measuring well-being. Visitor at Centre Maurice Halbwachs, CNRS, Paris and at Nuffield College, Oxford.

Member of the Editorial Boards of the journals Stato e mercato and Sociologia del lavoro. Referee of the journals: Journal of Ethnic and Migration Studies, British Journal of Industrial Relations, International Migration, International Migration Review, Socio-Economic Review, Social Forces, International Journal of Comparative Sociology, Geoforum, Polis.

**Anna Di Bartolomeo**. She holds a Ph.D. in Demography from the University of Rome "Sapienza". She was also educated at the Max Planck Institute for Demographic Research in Rostock and the Institute National d'Etudes Démographiques in Paris where she obtained the post-graduate diploma at the European Doctoral School of Demography. She is currently in charge of the demographic and economic module of the Consortium for Applied Research on International Migration (CARIM) at the European University Institute. Her research interests include international migrations and demographic determinants, migration and economic growth, integration of immigrants' children.

**Giuseppe Gabrielli.** He joined the University of Naples Federico II as assistant professor in 2014. Previously, he was technical assistant on Census data at the Italian National Statistical Office (2010-13). He held a post-doc position in Demography at the University of Bari – IT (2009-10); he was guest professor in Demography at the University of Macerata - IT (2007-08) and at University of Pescara - IT (2004-05). He was research fellow in Demography at the University of Bari (2006-07). He has held visiting position and/or fellow roles at the Max Planck Institute of Demography (Rostock - D) and at Brown University (Providence - RI), during the years 2004-08.

Salvatore Strozza. Full professor in Demography at the Department of Political Sciences, University of Naples Federico II, where he teaches Demographic Methods and Models and, Demography. Now he is vice-Director of the Department of Political Sciences. He is co-director of the Post-Graduate second Level Course in "Immigrazione e politiche pubbliche di accoglienza e integrazione" [Immigration and public policies of reception and integration]. He is associated in the research activity with the Research Institute on the Population and Social Politics (IRPPS) of the National Council of Research (CNR) and with International and European Forum of Migration Research (FIERI), collaborating with the Network of Excellence IMISCOE (International Migration, Integration and Social Cohesion in Europe). He is on the editorial board of two international journals: GENUS and STUDI EMIGRAZIONE/MIGRATION STUDIES. In the period 2006-2011, he was member of the Presidency Council of the Italian Society of Economy, Demography and Statistics (Società Italiana di Economia, Demografia e Statisstica - SIEDS). In the period from July 2013 to June 2015, he will be vice-President of the Italian Association for the Population Studies (Associazione Italiana per gli Studi di Popolazione - AISP) of Italian Statistical Society (Società Italiana di Statistica - SIS). His main area of research is international migration and foreign presence in Italy. His major contributions (more than 150 articles) concern the following issues: Sources and methods of measurement and estimates of migration and foreign population; Analysis of international migration in Europe; Demographic behaviours of migrants and consequences of international migration; Immigration and labour markets in the receiving country. The process of immigrants integration and school insertion of second generation; Geographical distribution of foreign immigrants.

**Ricard Zapata-Barrero.** Accredited Senior Professor of Political Science, he works at the Department of Political and Social Sciences, Universitat Pompeu Fabra (Barcelona-Spain) teaching on applied political theory and qualitative methods. His main lines of research deal with contemporary issues of liberal democracy in contexts of diversity, especially the relationship between democracy, citizenship and immigration. He is Director of GRITIM-UPF (Interdisciplinary Research Group on Immigration) and the Master Programme on immigration management at UPF. He is a participant and director in several European and National projects and research agreements. He founded in 2011 the Intercultural Cities

Network in Spain (RECI), in his capacity as an expert at the Council of Europe's intercultural cities programme. He is also a member of several research and government advisory boards, and a regular contributor to media and policy debates. **Angela Paparusso**. Ph.D. candidate in Demography at the Doctoral School in Statistical Sciences at the University of Rome "La Sapienza" with a research project on Italian immigration and integration policies. She graduated with honour in International Cooperation and Development, with a thesis on borders and migration in Europe that has been awarded by the Foundation "Roma Sapienza" for the "best master's degree in the discipline of Social Sciences". She recently finished the "European Master in Demography" – degree of the European Doctoral School of Demography (EDSD) – at the Autonomous University of Barcelona and she works for the "Rome Chapter" of the UNESCO Chair in "Population, Migrations and Development" of the University of Rome "La Sapienza".

**Alessandra de Rose**. She is Full Professor of Demography, at Sapienza University of Rome, Faculty of Economics. She is the President of AISP (Italian Association for Population Studies) and Member of Doctorial School in Demography, Sapienza University of Rome.

**Maurizio Ambrosini.** He teaches Sociology of Migrations at Milan University. He is also research director of the Centro studi Medì-Migrazioni nel Mediterraneo in Genoa, where he edits the journal «Mondi migranti» (published by Franco Angeli) and organizes the Summer School in Sociology of Migrations.

**Enza Roberta Petrillo**. Post-Doctoral Researcher in Political and Social Science at EuroSapienza. In 2013 she was selected as a Research Contract Agent in Human and Social Sciences by the Joint Research Centre of the European Commission. Graduated with mention in Political Science and Ph.D. in Development Geography, till October 2010, she was Research Fellow in Political Science and International Relations at the Pisa-based Sant' Anna School of Advanced Studies. Earlier, thanks to a grant awarded by the Italian Foreign Ministry, she was a visiting research fellow at the Faculty of Social Science of the University of Ljubljana, Slovenia. She has hold graduate and postgraduate seminars on the analysis of migratory flows, geopolitics and democratization processes.

As a practitioner, since 2006 to date, she has also worked for governmental institutions, international organizations and research centers, advising institutions such as OSCE, FAO, and the DG Migration of the Italian Ministry of Labour, FIERI and others. She has extensive experience in field research in Eastern European Countries and in analyzing complex political and social settings, using qualitative research methodology. She is member of Escape - Laboratory on Critical Studies on Forced Migration and of the European International Studies Association. Thanks to a grant awarded by the ISCH COST Action IS1101-Climate Change and Migration: Knowledge, Law and Policy, and Theory, since July 2014 she will spend one month as a visiting researcher at The Hague Institute for Global Justice, the Netherlands.

**Zoran Lapov**. Graduated in Ethnology and Russian language and literature (University of Zagreb), and specialised in the field of Intercultural studies (Univ. of Florence; International Univ. of Andalusia; Univ. of Granada). In 2004, Lapov completed his PhD in Methodologies of Pedagogical Research at the Department of Education (Univ. of Florence) with a thesis on non-territorial linguistic minorities in Italy: Roma and Sinti. For a socio-cultural and school policy. Combining anthropology, linguistics and pedagogy, Lapov's research

work is focused on cultural and linguistic diversity, identity dynamics, intercultural relations and mechanisms of social inclusion/exclusion with particular attention to minorities (esp. Roma communities) and migrations. In the same field, he delivers lectures and seminars, and participates in local, national and international research projects in collaboration with Italian and foreign universities and research centres. Lapov's research activity is best reflected in his numerous publications: we would like to mention the books Vaćaré romané? Diversità a confronto: percorsi delle identità Rom (FrancoAngeli, 2004), Dinamiche identitarie: multilinguismo ed educazione interculturale (L'Harmattan, 2001; with G. Campani), and Le esperienze ignorate. Giovani migranti tra accoglienza, indifferenza, ostilità (FrancoAngeli, 2002; with G. Campani and F. Carchedi), and his most recent articles: Caste Names as Identity Markers. The Case of Manganiyars (Subkulture, Maribor, Slovenia, 2012), Našardi Bori and her Stories: Framing Elopement in a Romani Community (Journal of Law & Social Research, Multan, Pakistan, 2013), and Intertwining Patterns of Social Positioning in Indo-Muslim Communities (Quaderni Asiatici, Milano, Italy, 2013).

**Ferruccio Pastore**. He holds a PhD from the European University Institute. He is Director of FIERI (International and European Forum for Migration Research, www.fieri.it), an independent research institute based in Turin (Italy), since May 2009.

He was previously Deputy Director of the International relations think-tank CeSPI (Centre for International Policy Studies, Rome) and a post-doctoral fellow at the University of Florence. Besides research, he has worked as an adviser on migration policy issues for Italian institutions (among which the National Council of Economy and Labour and the Schengen Parliamentary Committee) and international organizations (among which IOM and ILO).

His current research activities focus on the governance of labour migration in Europe and on the impact of the economic crisis on migration and integration processes.

**Francesca Fauri.** After graduating at the University of Florence (110/110 cum laude), I earned a master in International Affairs at the Johns Hopkins University (A-) and PHD in *Historia et Humanitate* at the European University Institute (1994). I have worked since then as a teaching assistant at the Faculty of Economics in Forlì and Rimini, won a two-year research contract at the Business History Unit of the London School of Economics and a post-doctoral fellowship at the Faculty of Economics in Bologna. In 1998, I was awarded a temporary teaching contract at Faculty of Political Science in Forlì (University of Bologna). Since 2001, I am a full time researcher at the Department of Economics and assistant professor of European Economic History at the Faculty of Political Sciences in Forlì. I am vice-president of the Scientific Committee of Europe Direct/Punto Europa in Forlì and in July 2011, I won an EU Jean Monnet Chair and the relative grant financing a research project on the economic history of migration. I also won a FARB project with the University of Bologna.

**Marie Bassi**. Graduated from the Sorbonne University in Political Science, I am a PhD candidate at the Center for International Studies and Research (CERI) of the Paris Institute of Political Studies (Science Po Paris). My thesis in Political Science addresses the local governance of immigration in Sicily, with a particular emphasis on local social movements on immigration and the interactions between public and non-state actors. My findings are based on 77 stakeholder interviews from 2010 to 2013. I also teach an elective course at the College Universitaire, Sciences Po Paris entitled « Governing Migration in Europe » and I work at the French Institute of International Relations as an associate Research Fellow at the "Center for Migrations and Citizenship".

**Roberta Ricucci**. Assistant Professor at the University of Turin (Italy), where she teaches Sociology of Interethnic relations and Sociology of Islam. She is also member of FIERI - International and European Forum of Migration Research and part of the steering committee of international and national scientific associations dealing with migration and religious issues. She has wide and varied experience of research on immigration issues and her recent research has generally been focused on immigrant children and second generations, investigating, especially among Muslims, their identity-building process and religiousness. Her most recent book is Second generation on the move. Children of immigrants coming of age, Lexington 2014.

**Lea Muller Funk.** Research Associate and University Assistant of Arabic Studies (University of Vienna). **S**ince 2011 PhD candidate at the University of Vienna, since 2012 PhD candidate at Sciences Po Paris.

**Thomas Lacroix.** He is CNRS research fellow in geography. He works on the relationships between immigrant transnationalism, development and integration. His work focuses on migrant social institutions such as associations and enterprises and their role in the shaping of transnational social fields. His Phd focused on Moroccan hometown associations in France, the Netherlands and Belgium and their engagement into development projects for the benefit of their place of origin (2003). Since then, he extended his research on other groups (Algerian Kabyles, Indian Punjabis, and Poles) in France and Great Britain. He was awarded a doctoral Marie Curie fellowship at the Centre for the Study of Migrations and Ethnicity (University of Liège, 2002-2003), a postdoctoral Lavoisier fellowship at the Centre for Research in Ethnic Relations (University of Warwick, 2005-2007) and a research fellowship funded by the Volkswagen Foundation the International Migration Institute (Oxford), associate editor of Migration Studies, editorial board member of e-migrinter and co-director of the Master programme International Migrations and Societies.

**Emanuela Trevisan Semi.** Professor of Modern Hebrew and Jewish Studies at the University of Ca' Foscari in Venice. She is the coordinator of a European Master in Crossing the Mediterranean. She has done research on Jewish marginal diasporas and especially on Karaites and Ethiopian Jews, also during the colonial Italian period. She is currently doing research on memory about the Jews of Morocco.

**Catherine de Wenden**. She holds a Ph.D. in political science from Sciences Po. Regular consultant for the OECD, the European Commission, UNHCR, and the Council of Europe. Chair of the Research Committee on Migrations of theInternational Society of Sociology since 2002; member of the Commission nationale de déontologie de la sécurité from 2003 to 2011; member of the editorial boards of *Hommes et migrations, Migrations société,* and *Esprit*. Lawyer and political scientist. Her research focuses on the relationship between migrations and politics in France, migration flows, migration policies and citizenship in Europe and in the rest of the world.

**Raimondo Cagiano de Azevedo**. He is Full Professor of Demography at the Faculty of Economics, University "La Sapienza" of Rome and Director of a Unesco Chair on "Population, Migrations and Development". He is Director of CUIA (Italian University Consortium for Argentina) and Deputy Rector for international affairs of the University "La Sapienza" of Rome. After graduating in Economics and Commerce at the University of Rome, "La Sapienza", he attended post-graduate courses in the Universities of Santander, Paris, Nice, and John Hopkins University, Bologna Center. He collaborated with the Foreign Office for statistical and demographic issues related to the main International Organizations: in this capacity, he was a member of the Italian Delegation at the European and World Population Conferences in 1974, 1982, 1984, 1993, 1994 and 2005. On several occasions, he has drawn up research reports on problems of migrations and population studies for various Administrations and International Organizations. He was President of the European Committee for the Population of the Council of Europe (Strasbourg). He was also Scientific Secretary of the National Committee on Population at the Premier's Cabinet of the Italian Government, Department of Social Affairs. He is member of the Editorial Board of the Reviews "Affari Sociali

Internazionali", "L'Europe en Formation", "Studi Emigrazione", "GENUS", "Welfare papers" and others.

**Enrico Pugliese**. He is professor of Sociology of labour at the University of Naples, Federico II. He is presently the director of Irpps-Cnr.

**Elena Ambrosetti**. Researcher in Demography at the Faculty of Economics and affiliated to the Department of Methods and Models for Economics, Territory and Finance - Sapienza University of Rome.

Her main fields of interest are: demography of the Mediterranean countries, population ageing, fertility transition, gender issues and migration in the Mediterranean area.

Before joining La Sapienza at the end of 2008, she has worked at the University of AixMarseille (France) as a Post doctoral teaching fellow and at INED (Paris) as a Post doctoral research fellow with FAO (Food and Agricultural Organisation) training funds. She holds a doctorate in Demography and Economics (2006) with honors from the Institut d'Etudes Politiques in Paris. She wrote her thesis on "Fertility Transition in Egypt" under the supervisor of Philippe Fargues (European University Institute, Florence). In 2001, she got a Master degree in Economics and Demography at the Institut d'Etudes Politiques in Paris working on "Social Exclusion in the Paris neighborhood" with Patrick Simon (Research scientist at INED). In March 2000 she graduated with honors in Business and Economics at Sapienza University of Rome. She wrote her final dissertation in Demography, under the supervision of professor Raimondo Cagiano de Azevedo. During her PhD she was research fellow at the Institut National d'études démographiques (INED) in Paris and visiting scholar at the Centre d'études et de documentation économiques, juridiques et sociales (CEDEJ) in Cairo and at the Social Research Center American University in Cairo. She worked as Research Assistant in Demography and Social Statistics at Sapienza University of Rome since 2001.

**Donatella Strangio.** Associate Professor in Economic History at the Faculty of Economics, Sapienza University of Rome, at the Department of Methods and Models for Economics, Territory and Finance. She holds a Ph.D. in Economic History from Naval University of Naples. Member of the Academic Board of the PhD Program in European History at Sapienza University of Rome. She has been a Research Fellow at the London School of Economics and at the the Maison des Sciences de l'Homme in Paris. Her principal works are on the famine in the preindustrial age, on the public finance and studies of institution and development and economic history of migration. She is member of the Italian Society of Economic Historians, of the Scientific Council of EuroSapienza Research Center, of the Scientific Committee of the Italian Association of Urban History, of the Economic History Association (Department of Economics – Santa Clara University) and of the Association for African Studies in Italy.
